Vendor Hours of Set up and Operations: Annapolis SET-UP TIMES ARE:

Thursday, March 11th, 4pm - Doors open 5pm-9:30 for Pre-Sale.

Friday, March 12th 8:30 am - Doors open to the public 9am - 5pm

Saturday, March 13th 7:30am - Doors open to public 8am – 3pm.

Sunday, March 14th 8:30am - Doors open to public 10am – 2pm

You are not required to be in attendance all days. We recommend you attend on during Friday and Saturday mornings as these will be the busiest times!

Vendor Hours of Set up and Operations: Easton SET-UP TIMES ARE:

Friday, April 16, 4pm to 5pm. Doors open 5pm-7 for Pre-Sale.

Saturday, April 17th 7:30am – 9am. Doors open to public 8am – 3pm.

Sunday, April 18th 8:30-9am. Doors open to public 10-2pm

You are not required to be in attendance all days. We recommend you attend on during the pre-sale night and Saturday morning as these will be the busiest times!

Wee-Sale, LLC is not responsible for lost or stolen products or display items. Please make arrangements to be staffed during all hours you have product out for sale.
