_____ 5. Pick up day is **Sunday Hours are 3PM-6PM**. I am encouraged to check the remaining racks & tables at that time for any missed items, and the lost & found table. Remaining items at 6PM on this day will be donated to area charities. Please leave an hour to gather all of your things. No exceptions, please as we have to vacate the building.

_____ 6. ALL CHECKS WILL BE MAILED TUESDAY & WEDNESDAY AFTER THE SALE!!! Thanks to our bar code system, we will be able to return a completed inventory sheet and your check soon after the sale ends!!!

_____ 7. Consignor agrees to hold harmless and make no claim against Wee-Sale LLC, the lessors of the space where the sale is held, any volunteer or insurer of Wee-Sale, LLC for the damage, theft or loss of any items consigned to Wee-Sale LLC. Wee-Sale LLC does not anticipate any theft, damage or loss, but occasionally these events may occur.

_____ 8. Consignor agrees to waive any and all claims for personal injury resulting from participation in Wee-Sale from whatever cause either foreseen or unforeseen against the Wee-Sale LLC, lessors of the space where the sale is held, volunteers, or paid participants in Wee-Sale, or the insurer of Wee-Sale.

_____ 9. **I certify, to the best of my knowledge, that none of the items I consigned have been recalled or been involved in an accident. I have checked the USCPA website safety, lead and Phthalates recalls. This applies to car seats as well and they must be manufactured less than 5 years ago.**

_____ 10. For a period of one year from the date identified below, Consignor covenants and agrees that Consignor shall not, without the express prior written consent of Wee-Sale, LLC (which consent may be given or withheld in the sole discretion of Wee-Sale), directly, indirectly or otherwise own, manage, operate, control, consult to, or be employed by, or otherwise be connected with, any firm, person, corporation, limited liability company, partnership, entity or enterprise engaged in **the business of consignment sales and resale's** (collectively referred to as "the Business") in the counties of Anne Arundel, Talbot, Caroline, Queen Anne's, in the State of MD, hereinafter referred to as the "Geographic Area," which Geographic Area constitutes the geographic area in which Wee-Sale LLC engages the Business at present time. Consignor is **not** prohibited from consigning items with other resale's or consignment sales. Consignor acknowledges that the restrictions set forth herein are reasonably necessary to protect the legitimate business interest of Wee-Sale. Consignor further acknowledges that Wee-Sale will actively conduct business in the Geographic Area and that all of the restrictions contained herein are reasonable in all respects, including duration, geographic territory and scope of activity restricted. In the event of any legal action between the parties arising out of or in relation to this Consignor Agreement, Wee-Sale LLC shall be entitled to recover from Consignor, in addition to any other legal remedies, all of its costs and expenses, including, without limitation, reasonable attorney's fees, regardless of whether such legal action is prosecuted to completion.
